All Withdrawals before the Freeze Deadline **MUST** be made within a player's IPIN account.

All Withdrawals after the Freeze Deadline must be made on this official form and sent to both the ITF & ITF Supervisor:

2. ITF Supervisor (Contact available on the Fact Sheet in IPIN.)

Withdrawal deadline: 14:00 hours GMT, Tuesday thirteen (13) days prior to the Tournament Week (Main Draw & Qualifying).

Freeze deadline: 14:00 hours GMT on Thursday preceding the Tournament Week.

This form is NOT valid for tournament entries.

IMPORTANT

LATE WITHDRAWALS

Please note, All withdrawals submitted after the Withdrawal Deadline are considered "late", and are subject to penalty under the ITF Code of Conduct. (Please read the Men's ITF World Tennis Tour Regulations and Code of Conduct)

* The first three late withdrawals in a calendar year are not penalised by the ITF and the fines will be cancelled with a "withdrawal amnesty", provided the player withdraws prior to the Qualifying Sign-in Deadline. (Players that do not submit a form will receive a No Show penalty.) Starting on the 4th late withdrawal and onwards, all players will receive a late withdrawal penalty, which includes a fine.

* Players that withdraw to play another tournament (example: ATP/ATP Challenger) after the Freeze Deadline are penalised by the ITF for playing another tournament. Players should therefore withdraw from all ITF tournaments they no longer wish to play before the Freeze Deadline.

Note: Players that need to withdraw for injury/illness off-site should use their three free late withdrawals

* Only valid medical certificates obtained at ITF World Tennis Tour, ATP Tour, ATP Challenger Tournaments that meet the specific circumstances and regulations of the Men's ITF World Tennis Tour will be considered.

* For full details about the procedures and consequences of late withdrawals please refer to the Men's ITF World Tennis Tour Rules and Regulations, and Code of Conduct, available on the ITF website.
