Match Format, Match Balls & Practice Courts

Singles Scoring Format: Best of 3 tie-break sets in all main draw singles matches
Singles Qualifying (if required) 2 tie-break sets and 10-point match tie-break

Singles Consolation: Consolation singles will play an abbreviated scoring format which will be communicated on site. All players must sign in on site to play consolation. More information on consolation singles can be seen below.

Doubles Scoring Format: Two Tie Break Sets and a 10-point match tie-break in all matches

Tournament Ball: Wilson US Open

Practice Courts

Practice courts will be available at venues in Palm Beach Gardens from 12.00 noon on Thursday 30 April. Practice courts will also be available from 11am on Friday 1 May 2020 for those in the individual event. Details on how to book practice courts will be available here in March 2020

Please note, official transport in Palm Beach Gardens will be available from Friday 1 May 2020 only. Players who wish to practice on Thursday 30 April must travel privately.

Wilson US Open balls will be provided for practice at each venue for a small refundable deposit subject to balls being returned within 48 hours. Balls returned after 48hrs from time of deposit will not be accepted.

Tournament Dates:

Saturday 2 May – Saturday 9 May 2020

Entries Open: 6 January 2020 (using you ipin account at www.itftennis.com/ipin)

Entry Deadline: Monday 20 April 2020 at 10.00hrs GMT

Withdrawal Deadline: Tuesday 28 April 2020 at 10.00hrs GMT

Doubles Matching:

** Players that are in the doubles entry list and have not confirmed a partner or withdrawn by the Doubles matching deadline will be paired with another player requiring a partner by the ITF – further details will be provided.*

Tournament Dates: Saturday 2 May to Saturday 9 May 2020. A more detailed breakdown of event plan will be available on the ITF website prior to the entry deadline

Draws and Order of Play (for first day of play) are expected to be published on Wednesday 29 April 2020 between 6pm-8pm (local time). The latest publish time shall be Thursday.

Finals: Saturday 9 May 2020 at Ballenises Country Club. Some doubles finals may conclude on Friday 8 May 2020 at discretion of Referee

The above deadlines will be strictly applied to all competitors without exception.

Main Draw and Qualifying Draw

Maximum Main Draw Size:

128 in the singles events and 64 in the doubles/mixed doubles events.

*If a singles main draw size of 128 is exceeded, a maximum qualifying draw size of 32 will take place

Qualifying:

If the number of entries exceeds the draw size of 128 in any draw, a qualifying event may be held immediately prior to the main draw. Players will be accepted according to Section 1, Rule 27 of the criteria for acceptances in the 2020 ITF Seniors Regulations. Players will be advised of their position once the entry deadline has passed.

Qualifying (if required) will take place on Saturday 2 May 2020. Players may be required to compete in 2 singles matches on the same day where qualifying draws are held.

Entries

Please note that players must have a valid Seniors IPIN membership in order to enter and compete.

Singles Entries

Online entry will open 6 January 2020, through the IPIN account of each player (www.itftennis.com/ipin). All players are required to enter and pay by the due deadline (**Monday 20 April 2020 at 10.00hrs GMT**).

THERE WILL BE NO SIGN-IN ON SITE. It is the responsibility of the player to ensure that the (online) entry procedure has been successful.

Main Draw Singles Event

The Main Draw is scheduled to commence on Saturday 2 May 2020. **All players must be available to play on this date if required.** If a player receives a bye in the first round, they may not be required on the first scheduled day. A tentative schedule of when each event will start will be available prior to the tournament.

Doubles/Mixed Doubles Entries

Doubles and mixed doubles events will be held in all age categories, using the format two tiebreak sets and a match tie-break in place of a third set.

All references to doubles below also include mixed doubles.

Doubles/Mixed Doubles entries will close on Tuesday 28 April 2020 at 10.00hrs GMT (Withdrawal date for Singles). Players may enter without a partner. Where possible, any player that appears in the entry list after the entry deadline without a partner will be paired with another player who has also entered without a partner by the ITF office.

There will be NO doubles sign in on-site

Consolation Event

Consolation events for first match singles losers shall be held. ITF Seniors World Ranking points will be awarded in the Consolation event. New tennis balls will be used. Players who get a walkover in their first match and lose their second may choose whether to receive the ranking points won from this walkover win or to play the consolation event.

Entry is a 2-stage process:

Stage 1 – Entries must be made via IPIN. A link will be provided here when entries open in January 2020.
Stage 2 – Entry fee to be paid online. Link will be provided here in January 2020 when entries open.

All players must have a valid Seniors IPIN in order to compete and pay the entry fee and IPIN fee

Entry Fee & IPIN Payment:

Entry Fee: USD \$150.00

IPIN Fee: USD \$6.00

According to section I, rule 54 of the ITF Seniors Regulations, entries **will NOT be accepted without the entry fee of US\$150 (approx. €132)** plus payment of the IPIN fee which **is payable by the entry deadline** per person whether for entry into singles and/or doubles and/or Mixed Doubles.

Players may enter up to three events (one singles, one doubles and one mixed doubles). Please note that any player entering three events must be prepared to play three matches in a day.

Method of payment – Link will be provided here in January 2020 when entries open.

Refunds: Refunds in full will be made if withdrawal is notified **before the withdrawal deadline of Tuesday 28 April 2020 at 10:00am GMT**. If withdrawal is notified **after the withdrawal deadline**, refunds will only be made for reasons of health/injury if supported by a medical certificate or bereavement. Withdrawals after the draw has been made will not be refunded.

Hospitality Money

Hospitality monies will be paid for Main Draw events only (not for Consolation events), as follows:

Singles winners: US\$800.00

Singles runners-up: US\$500.00

Doubles/Mixed Doubles winners: US\$600.00 per team

Doubles/Mixed Doubles runners-up: US\$300.00 per team

Payment will be made following the Event, either by cheque (US\$ or £GBP) or bank transfer.

Please note that payments can only be processed until 1 month after the tournament end date. After this date, payments will not be made.

Official Tournament Dinner / Player Party: A Party on the beach.

Beach Tennis will be set up for players to try from 5pm – 7pm (tbc. depending on location of turtle nests)

Date: Tuesday 5 May 2020

Time: 7.30pm

Venue: Dinner at the Hilton on Singer Island.

Cost: \$30 for players / \$40 for Guests.

Cost includes transport, drink ticket, dinner and dancing.

Deadline: Monday 4 May (2pm).

Reservations: Accepted at all venues

Medal Ceremony

Medal ceremony will take place on Saturday 9 May 2020 at Balleniesles Country Club. Medals shall be presented to Winner(s), Runner Up(s), Semi Finalists in all events, plus Singles Consolation Winners. All medallists are required to attend the medal ceremony.

Official Tournament Hotels

Official tournament hotels can only be booked through [Event Connect](#). A special rate has been agreed at the following hotels in Palm Beach Gardens which are available to book through Event Connect.

Airport Travel and Transport Details

Recommended Airports

- [Palm Beach International \(PBI\) Airport](#) - approximately 20 minutes from Palm Beach Gardens
- [Fort Lauderdale \(FLL\) International Airport](#) - approximately 1 hour from Palm Beach Gardens
- [Miami \(MIA\) International Airport](#) - approximately 1 hour 15 minutes from Palm Beach Gardens

Tri-Rail

Available from Miami and Fort Lauderdale airports to Palm Beach Gardens. Cost is approximately \$10 per person. 'Mangolia Park' station is the nearest Tri Rail station to hotels and venues. Uber or Lyft is available from Tri-Rail stations to official hotels and will cost approximately \$15-20 per vehicle.

Brightline Trains

An alternative to Tri-Rail is Brightline which is a relatively new train service in South Florida. Brightline have stations located in Fort Lauderdale, Miami and Palm Beach. See more at www.gobrightline.com/

Uber or Lyft Transfers

Tournament Travel and Transport Details

Bus transportation from the Official Hotels only to the tournament sites will be available each day starting Friday 1 May 2020. Bus schedule times will be posted. On match days buses will leave Official Hotels at least 1 hour before match times. Buses will depart each day from the sites to the hotels after play is complete. A thorough transport schedule will be available in April.

Transport to Palm Beach Gardens for Individual Event

For those competing in the Team Event in Boca Raton, Buses will depart from the Official Hotels in Boca Raton on Friday 1 May (PM) and Saturday May 2 (at 9am) for players playing in the Individual World Championships being played in Palm Beach Gardens (45 minutes from Boca Raton). A Sports Medicine Physiotherapist (Trainer) will be on site from Saturday 2 May 2020 until the end of the tournament. Physio will be on site 30 minutes before play and until 10 mins after the end of play each day.

Treatment to players on court during matches will not be charged.

Players can book a private treatment with a Physio at a cost of \$25.00. Payment must be made prior to the treatment commencing by cash or card. More information will be available on site.
